Re: Report of Inspector of Elections

Dear Andy:

At the request of the Bristol Bay Regional Seafood Development Association, Inc. we have served as Inspectors of Election pursuant to the terms of our revised agreement dated February 2, 2021 and the Elections of the Board of Directors Policies and Procedures (revised January 22, 2021) obtained from the BBRSDA Policies and Procedures Manual.

Pursuant to the terms of the above Policies and Procedures, we directly received via the mail all return envelopes, which contained the ballots.

On the afternoon of Thursday, May 6, 2021 we began the process of opening return envelopes postmarked April 29, 2021 or prior and received by May 5, 2021. Once the return envelopes were opened by TH&G the information on the outside of Identification Envelope (Envelope #2) was compared to the CFEC list of eligible voters.

The identification envelopes were then stored unopened in a locked file cabinet at the office of Thomas, Head & Greisen, PC.

On Friday, May 7, 2021 the process of matching identifying information on Envelopes #2 (as described above) was completed. Next, the ballot envelopes were removed unopened from the identification envelopes by TH&G personnel. The ballot envelopes were then opened, and the ballots collected in a box. The ballots were shuffled and then counted; the first count of votes was recorded on a tally sheet at that time. All items were locked away again between close of business on Friday and opening of business on Monday, May 10, 2021.

On Monday, May 10, 2021 the second count by the initial ballot counter was completed. The tally sheet was then verified (by means of a 3<sup>rd</sup> count) by TH&G staff who had not performed the original count.

At no time after their receipt by mail did the ballots leave the office of Thomas, Head & Greisen, PC or possession of the inspector of elections.

Attached to this letter please find the result of the vote count we completed on Monday, May 10, 2021.

We have also included a separate page providing statistical information with respect to items received by our office this election cycle that were not included in the count of eligible ballots.
